INVESTIGATORS NOTES

On October 29, at approximately 1:15 p.m. I was contacted by Sergeant JOHN CARTER of the Arkansas State Police Criminal Division. Sgt. CARTER relayed to me that he had received a telephone call from Deputy Prosecutor MARTIN LILLY of Poinsett County. The nature of the call was in regards to a 19 year old female that resides in Marked Tree, Arkansas and was approached by two females requesting her to apply for an absentee ballot for the general election. The female was identified to me as PATRICE POWELL in which stated to the Prosecutor that RUBY JEAN BOXLEY had approached her to complete the absentee ballot but stood over her shoulder and displayed strong opposition to her choices. POWELL stated that she felt intimidated by BOXLEY and had concerns that her ballot did not get turned into the courthouse with the selections she made.

S.A. RAMEY LOVIN and I traveled to Marked Tree and interviewed PATRICE POWELL as well as RUBY JEAN BOXLEY. In addition JOHN E. BOXLEY was interviewed as well when it was learned he was the person signing the ballot out of the courthouse that PATRICE POWELL completed.

These interviews will become a part of this case file for further review.

PATRICE POWELL was interviewed on October 29, 2010 at approximately 2:10 p.m. at her residence in Marked Tree, Arkansas. An ASP 6B Description of Subject Form was completed on POWELL prior to this interview. Officers present were S.A. RAMEY LOVAN and S.A. MIKE GRIMES of the Arkansas State Police. POWELL gave the following information.

PATRICE POWELL stated she was outside getting ready to go to school and Mrs. BOXLEY came up to her and stated that "your brother told me to give you his voting papers". POWELL stated that her brother is EDWARD POWELL. POWELL stated that BOXLEY told her "if she signed her name that she could get yours too". POWELL stated that she was a first time voter and did not know how the process works and told her that would be ok. POWELL stated that she went to school and came back home and received a telephone call from BOXLEY stating that she was coming back over to bring her the paperwork. POWELL stated that BOXLEY arrived at her home and said "here is your voting paper". POWELL stated that she thought she was going to be able to mail them in. POWELL stated that they sat down and BOXLEY ask her "how did you get registered". POWELL stated that she told BOXLEY that Mr. DEWAYNE NICHOLS helped her register to vote. POWELL stated that was when it all went down the drain. POWELL stated that BOXLEY at that point told her how NICHOLS was a liar and that she should not vote for him. POWELL stated that she told BOXLEY that she was still going to vote for NICHOLS because she likes him. POWELL stated that BOXLEY told her that "if she was not going to vote for DIXON, I had rather you leave it blank". POWELL stated that she still voted for Mr. DEWAYNE because she did not want her to persuade her voting.

POWELL stated that her brother EDWARD POWELL came home at that time and BOXLEY made that statement "I'm going to tell your brother how you voted because he is going to vote for DIXON". POWELL stated that her brother voted for NICHOLS also and that this made BOXLEY all mad again.

POWELL stated that someone told her that the lady that was with BOXLEY was the current mayor's wife but she did not know that for sure. POWELL stated that her brother called her that night and told her that BOXLEY and the other lady went to the current mayor and told them how they voted. POWELL stated that after the current mayor heard that information, he went to her uncle EDDIE MITCHELL and asks "why did that POWELL boy and girl not vote for him". POWELL stated that her uncle is over the parks in that area.

POWELL stated that there were other parties on the ballot but BOXLEY'S main concern was the mayor's race. POWELL stated that she knew that BOXLEY had been going mainly to the black neighborhoods and getting the older black voters to vote for DIXON. POWELL stated that most of the ones that she approached don't care and she knows that. POWELL stated that the paper that she signed was so BOXLEY could be a bearer for the paperwork. POWELL stated that she did not know what BOXLEY position was at the city but if she could sign off on grants she must hold some position in the city. POWELL stated that she called FONDA CONDRA and asked if she received her ballot. POWELL stated that CONDRA told her that she did receive the ballot and if she wrote it in ink it could not be erased.

POWELL stated that the lady that was with BOXLEY was stating that she should not vote for NICHOLS also but was not as vocal about her decision as BOXLEY was. POWELL stated that the ladies came up in a newer Mercury Marquis the first time but came back in an older grey Cadillac Deville the second time.

RUBY BOXLEY was interviewed on October 29, 2010 at 3:31 p.m. at her residence in Marked Tree, Arkansas. An ASP 6B Description of Subject Form was completed on BOXLEY prior to this interview. Officers present were S.A. RAMEY LOVAN and S.A. MIKE GRIMES of the Arkansas State Police. BOXLEY gave the following information.

RUBY BOXLEY stated that she had ran into EDWARD POWELL and asked him if he was going to vote. BOXLEY stated that EDWARD POWELL told her yes, he was and that he was going to vote for DIXON. BOXLEY stated that she told him if he was going to vote for DIXON she would get him an absentee ballot. BOXLEY stated she explained the process that he would have to sign in order for someone to retrieve the absentee ballot and TOMMY CHANDLER signed for him. BOXLEY stated that she looked at the voter registrations and noticed that there was PATRICE POWELL listed at the same address as EDWARD'S address and wondered if he was married. BOXLEY stated that she went over there and spoke with PATRICE and obtained a signature from her to receive an absentee ballot as well. BOXLEY stated that they went to the courthouse and picked up the ballots and returned to the POWELL'S address. BOXLEY stated that as they were going down the names on the ballot, BOXLEY states PATRICE was mad. BOXLEY stated that PATRICE told her "I'm going to vote for WAYNE NICHOLS". BOXLEY stated that she would have not went and got the ballot if she knew that she was not going to vote for her candidate. BOXLEY stated that at that time POWELL started telling her all of the things that NICHOLS had told her. BOXLEY stated that POWELL told her that NICHOLS stated that the city had spent all the money on the park that they have out here. BOXLEY stated that she told her that is not the truth and that she personally wrote the grant for \$95,000 dollars to build the walking trail in which they got. BOXLEY stated that NICKEY WALKER wrote the grant for \$ 250,000 dollars to build the park, so NICHOLS comments were not true.

BOXLEY stated that it was her understanding that EDWARD POWELL and PATRICE POWELL told her before they went and got the ballots that they both were going to vote for DIXON CHANDLER. BOXLEY stated that they both sealed their ballots and voted the way they wanted to.

BOXLEY stated that PATRICE asked her if she went and asked Mr. WAYNE if she could see those grants would they be there. BOXLEY stated that she felt when PATRICE went and told WAYNE NICHOLS what was said, he was the one that told her to file a complaint. BOXLEY was adamant that PATRICE would not know who or how to complain to anyone.

BOXLEY stated that TOMMY CHANDLER the mayor's wife was present during the filling out of the ballots at the POWELL residence. BOXLEY stated that EDWARD was mad too and stated that he has heard some things and he was changing his mind and voting for NICHOLS. BOXLEY stated that she told them why did they not tell her that they had changed their mind, she now has to make another trip to Harrisburg to turn them in. BOXLEY stated that it was not like she could just drive up into town and turn them in.

BOXLEY stated that EDWARD told her that he was mad because when he went up to talk to DIXON CHANDLER, he would not speak to him. BOXLEY was asked by this agent who signed off on the affidavit on PATRICE POWELL'S ballot and if that person was present during the completion of the ballot. BOXLEY stated that her son JOHN BOXLEY did but he was not present when the ballot was filled out. BOXLEY stated that she did not know that this was a stipulation on being present during the completion of the ballot.

BOXLEY admitted that she was upset that both of the POWELL'S did not vote the way that they had indicated to her. BOXLEY maintains that PATRICE would not know how to make a complaint and she is sure that this is coming from WAYNE NICHOLS putting her up to the complaint.

JOHN BOXLEY stated that it was his impression that it did not make any difference if he was present or not when the ballots are filled out. BOXLEY stated that he was the one that signed out and returned PATRICE POWELL'S ballot from the Poinsett County Courthouse. BOXLEY stated that this issue has never come up before and he has never been told to be present during the completion of the ballots.
