Libertarian Candidate Aaron Cash is the only Conservative candidate legally eligible to be elected Attorney General this year. Leslie Rutledge is guilty of multiple counts of Voter Fraud and cannot be elected to hold office. Leslie Rutledge is NOT a Qualified Elector under the Arkansas Constitution. A person cannot vote as a "qualified elector" in Arkansas if not legally registered.

A person cannot be elected to office unless he or she is a qualified elector. The Arkansas Constitution amend 51, sec. 11, says voters are registered unless they cancel their registration or are subject to cancellation--including Registering to Vote outside the county where previously registered. A person CANNOT be a qualified elector (registered to vote) in two states at the SAME time. The voter chooses which state to register in.

LESLIE RUTLEDGE IS NOT LEGALLY REGISTERED TO VOTE IN ARKANSAS!

LESLIE RUTLEDGE IS CURRENTLY REGISTERED TO VOTE IN VIRGINIA NOT ARKANSAS!!!

Leslie Rutledge's Voter registration History:

| 2006 | Registered in Pulaski Co. Ark |
| July 2008. | Registered in Washington DC
November 2008 VOTED in Ark. --ONLY 4 months after registering in Washington DC (Did she forget that she moved to Washington and declared her residency and domicile and registered to vote there 4 months before she cast an illegal ballot here??) |
| 2010 | Registered to Vote in The State of of Virginia. She is STILL REGISTERED TO VOTE IN VIRGINIA |
| 2014 | Votes for herself in Arkansas's Republican Primary and Run off and Never Registered to Vote Upon Moving Back To Arkansas |

NOTE: When Asa Hutchinson moved back from Virginia, he registered to legally vote in Arkansas. This isn't a technicality! This is fundamental to our system of government. She wants to be the state's lawyer? Clearly she isn't much for paying attention to detail!

But the politicians are all the same.

- Why doesn't Democratic County Clerk Larry Crane remove her from the voter registration roll?
- Will Larry Crane Require her to register to vote before the November election?
- Will Secretary of State Mark Martin declare her in eligible to be on the ballot?
- Will Larry Jegley prosecute her for voter fraud?
- Will Brian King offer her as an exhibit of ACTUAL voter fraud justifying Voter ID law?

Will the press do its job and ask hard questions? Will they demand that she:

- Release Documentation Explaining her “**Gross Misconduct**” at the DHS
- If she refuses to release her records: Why does she think we have no right to see them??
- Explain Why *Despite being registered in two states and Washington, DC at the same time*, she didn't even attempt to vote between 2008-2013
- Tell us once and for all why she had to leave Gov. Huckabee's Staff
- Explain why she has never registered her law firm as a business in Arkansas
- ***Will she Register to vote before November or will she attempt to cast another illegal Ballot?***

She is not a Qualified Elector and Ballots cast for her must not be counted

If she attempts to vote at all without properly registering before October 6th, her ballot will be challenged
