Dear Mr. Crane:

I have set out the facts surrounding my qualifications as a resident and as a voter in Pulaski County and respectfully request that you add my name back to the voter roll.

At the beginning of 2013, I moved back to my home in Little Rock and established residency. Then, on March 7, 2013, I came to your office at the Pulaski County Courthouse for the specific purpose of registering to vote at my home address in Pulaski County. I presented a member of your staff with my voter registration form and stated that I wished to change my voter registration from Virginia back to Pulaski County. Your office informed me that I was already on the voter roll in Pulaski County listed under a previously held address in Little Rock and refused to accept my registration application. After I explained several times that I was moving from Virginia back to Little Rock and that I did not live at the address on file, the staff member insisted that I complete the change of address form. I complied based on repeated assurances from the member of your staff that this would register me to vote in Arkansas as a resident of the address listed. I was assured by your office that this was the proper procedure and the proper form to ensure that I would be legally registered to vote. A few days later, I received my voter registration card from your office dated 8th day of March of 2013 certifying that I was a legally registered voter in Pulaski County, AR (a copy is attached to this letter).

Since March of 2013, I have voted in four elections in Pulaski County, all of which were certified by your office. I provided my photo identification when voting and was confirmed to be in good standing on the Arkansas voter rolls by the election workers each time I voted.

Late Tuesday afternoon, I received a phone call from your office informing me that my name was being removed from the voter roll without any notification or opportunity to present the facts. After sending a copy of my voter registration card electronically to your office, I was informed via email at close of business (4:35 p.m.) that I had been removed from the roll.

I respectfully request, under my right as a resident of Pulaski County and citizen in good standing with the State of Arkansas, that you withdraw your illegal cancellation and reinstate my voter registration in Pulaski County, Arkansas, by 4:00 p.m. CST, on October 2, 2014.
