<i>Executive Order Title</i>	20-52	12/21/2020
<i>Determination Summary</i>	<p>Executive Order Pursuant to the Public Health Emergency Concerning Covid-19, as Declared by Executive Order 20-37 and Extended by Executive Orders 20-45, 20-48, 20-51 for the Purpose of Amending Executive Order 20-34 to Ensure Access to Healthcare Resources to Treat Covid-19</p> <p>The original intent of this EO Pursuant to the Public Health Emergency Concerning Covid-19, as Declared by Executive Order 20-37 and Extended by Executive Orders 20-45, 20-48, 20-51 for the Purpose of Amending Executive Order 20-34 to Ensure Access to Healthcare Resources to Treat Covid-19 by Public Responders. Superseded EO 20-34.</p> <p>In consultation with the Center for Medicare and Medicaid Services (CMS), the Arkansas Department of Health (ADH) issued a temporary hospital license for licensed ambulatory surgery centers. Act 723 of 2021 provided guidance for insurers that contracted with temporary hospital facilities and their conversion back. Act 1055 of 2021 clarified that ADH has authority to continue the regulatory flexibilities for the duration of the CMS Hospitals Without Walls Initiative. The temporary hospital licenses would remain in place until the CMS waiver is terminated by CMS or the current national public health emergency is declared over. Under Act 510 of 2021, certain liability protections were extended for hospitals as protections for physicians, physician assistants, specialist assistants, nurse practitioners, licensed RNs, and licensed practical nurses that provided care to contain and treat the disease cannot be sued because of their efforts to mitigate its spread. Health care workers redeployed and practicing outside their normal scope of practice to alleviate the burden enjoyed blanket immunity protections for an additional two (2) years.</p>

<i>Determination Summary</i>	<p>To Declare an Emergency, as Authorized by Ark Code Ann. § 12-75-114, and Order the Arkansas Oil and Gas Commission to Take Immediate Action to Prevent the Waste of Oil and Gas Resources</p> <p>The original intent of the EO was to declare an emergency and order the AR Oil and Gas Commission to take immediate action to prevent the waste of oil and gas resources. There were no permanent rule amendments made because of EO 20-24. The Oil and Gas Commission issued a series of Commission Orders to implement the operational provisions of the EO; however, all of the rule waiver provisions and fee waivers outlined in the EO, and implemented by the Commission, have ended and normal regulatory operations were reinstated.</p>

<i>Determination Summary</i>	<p>Executive Order to Establish the Governor's Economic Recovery Task Force</p> <p>The original intent of the EO was to establish the Governor's Economic Recovery Task Force. Many committees and task forces like this have been repealed by EO 23-09.</p>

<i>Determination Summary</i>	<p>Executive Order directing State Agencies to provide funds from federal grants and contracts for reimbursement of the Miscellaneous Revolving Fund for unemployment payments made as a result of such grants</p> <p>Recommendation: Revoke this Executive Order; necessary provisions are codified.</p> <p>The intent of this Executive Order is codified in A.C.A. § 19-5-701-708 and further outlined in policies contained in the Financial Management Guide published by the Department of Finance and Administration.</p> <p>A.C.A. § 19-5-708 states that a state agency shall not make contributions of more than 3% of a state agency's gross payroll expenditures, which conflicts with 1% as stated in the executive order. In addition, the fund to which the monies are deposited is the Unemployment Compensation Trust Fund, not the Miscellaneous Revolving Fund as stated in the executive order.</p>

<i>Executive Order Title</i>	98-04	02/27/1998
	Establishing mandatory guidelines and procedures in areas of employment, grants, contracts and purchasing	
<i>Determination Summary</i>	<p>Recommendation: The Executive Order has more stringent reporting requirements than the statutes with which it conflicts. This conflict can be resolved either through legislative action or by revoking this Executive Order. The point of the Executive Order is transparency. If the goal is the highest level of transparency, then this Executive Order should be incorporated into the statutes through legislation. If the goal is less restrictive reporting requirements, then this Executive Order can be revoked, leaving the current statutes in place.</p> <p>Potential Impact: The provisions of this Executive Order affect current, former, and future State of Arkansas employees, boards or commission members, constitutional officers, and the spouses or immediate family members of those listed if they seek employment, grants, contracts, or purchasing within Arkansas government.</p> <p>Conflicts: A.C.A. §§ 19-11-700 et seq., 19-11-264 (Act 567 of 2007), 21-1-401 (Act 34 of 1999), 25-16-1001 (Act 2262 of 2005), and EO 98-04 Rules Promulgated by DFA (Rules # 006.27.05-002)</p>	
<i>Summary of Conflicts</i>	<p>The term “constitutional officer” includes members of the Arkansas House of Representatives and the Arkansas Senate, the Governor, Lieutenant Governor, Secretary of State, Treasurer of State, Attorney General, Commissioner of State Lands, and Auditor of State.</p> <p>The term “Rules” refers to Rule # 006.27.05-002 promulgated by the Department of Finance and Administration (DFA) Office of State Procurement on December 2, 2005. These rules were promulgated to implement EO 98-04, Act 34 of 1999, and Act 2262 of 2005.</p> <p><u>I. Disclosure Requirements</u></p> <p>a. Contractor Disclosure</p> <p>EO 98-04 requires individuals desiring to obtain or renew a contract, lease, purchase agreement, or grant with any state agency to disclose whether that person is a current or former: Constitutional Officer, Board or Commission Member, State Employee, or the spouse or immediate family member of any persons described above.</p> <p>EO 98-04 requires any non-individual entity desiring to contract with, or receive any grant benefits from, any state agency to disclose (1) any position of control, or (2) any ownership interest of 10% or greater, that is held by a current or former: Constitutional Officer, Board or Commission Member, State Employee, or the spouse or immediate family member of any persons described above.</p> <p>b. Subcontractor Disclosure</p> <p>EO 98-04 requires any contractor desiring to obtain or renew a contract, lease, purchase agreement, or grant with any state agency to require any subcontractor, sub-lessor, or other assignee, to disclose whether such subcontractor is a current or former:</p>	

Recommended Repeal: Conflicts

Constitutional Officer, Board or Commission Member, State Employee, or the spouse or immediate family member of any persons described above.

EO 98-04 also requires disclosure if any of the persons listed above holds (1) any position of control, or (2) any ownership interest of 10% or greater in the subcontracted entity.

The Rules require disclosure by all parties listed in EO 98-04; however, any contract or subcontract less than \$25,000 are exempt from disclosure.

A.C.A. § 21-1-404 authorizes the Secretary of the Department of Finance and Administration to promulgate and implement any necessary rules or policies to ensure compliance with A.C.A. §§ 21-1-401-408, and requires that all disclosure statements and other information furnished by constitutional officers and their spouses shall be certified by the constitutional officer or spouse under penalty of perjury.

Conflict 1:

A.C.A. § 21-1-404(b) does not include the immediate family member of constitutional officer as a relationship that must be certified by the constitutional officer; however, EO 98-04 and the Rules do require the immediate family member of a constitutional officer to be disclosed.

Conflict 2:

A.C.A. §§ 21-1-401-408, does not specify that these laws also apply to a former constitutional officer or their spouse; however, EO 98-04 and the Rules do state that disclosure is required for former constitutional officers and their spouses.

Conflict 3:

A.C.A. § 21-1-404(a) gives the Secretary of the Department of Finance and Administration (DFA) the authority to promulgate rules associated with disclosures. With the 2019 transformation of state government, the Office of State Procurement was transferred to the Department of Transformation and Shared Services (TSS); therefore, any changes to the Rules should now be promulgated by TSS.

Conflict 4:

The Rules are less restrictive than EO 98-04 by exempting agencies from requiring disclosure, whether an individual or entity, for which the total consideration is less than or equal to \$25,000.

Conflict 5:

Additionally, the Rules do not include the requirement that grants are required to be disclosed.

II. Agency Reporting

EO 98-04 requires agencies to report all (1) grants awarded to, and (2) all goods and services sold or leased to them by, a current or former: Constitutional Officer, Board or Commission Member, State Employee, the spouse or immediate family member of the persons described above, or

If any of the persons listed above holds (1) any position of control, or (2) any ownership interest of 10% or greater in the business entity.

Conflict 6:

A.C.A. § 21-1-403 does not include restriction on former constitutional officers or the spouse or immediate family member of the constitutional officer; therefore, this would only be captured through EO 98-04. As such, the Rules also do not require agencies to report such information.

Recommended Repeal: Conflicts

Because conflict 4 exists, reporting is not required for contracts, leases, or purchase agreements below \$25,000 and is therefore not obtained from the individual or entity entering into or renewing a contract, lease, or purchase agreement with an agency.

Additionally, because conflict 5 exists, reporting is not required for grants by employees, board or commission members or their immediate family members, to include their spouse or legal entities owned in part by them.

III. Prohibition of Contracts and Grants

EO 98-04 prohibits agencies from entering into or renewing any contract, lease, purchase agreement, or grant with any current or former: Constitutional Officer, Board or Commission Member, State Employee, the spouse or immediate family member of the persons described above, or

If any of the persons listed above holds (1) any position of control, or (2) any ownership interest of 10% or greater in the business entity.

This prohibition does not apply to:

- Contracts, leases, or purchase agreements that are the result of competitive sealed bidding, or a request for proposal,
- Contracts, leases, or purchase agreements subject to competitive bidding, for which the total consideration is less than \$10,000, or
- Contracts, leases, purchase agreements, or grants not subject to competitive sealed bidding or a request for proposal, for which the total consideration is \$10,000 or greater.
 - Prior written approval of the CFO of the State shall be obtained, and
 - Notice is given to the Governor and Arkansas Legislative Council.

The limits for competitive bidding and competitive sealed bidding have increased since EO 98-04 was issued.

- 1998 Competitive Bidding > \$1,000 and < or = \$10,000
- 1998 Competitive Sealed Bidding > \$10,000
- 2001 Competitive Bidding > \$10,000 and < or = \$25,000
- 2001 Competitive Sealed Bidding > \$25,000
- 2013 Competitive Bidding > \$10,000 and < or = \$50,000
- 2013 Competitive Sealed Bidding > \$50,000
- 2017 Competitive Bidding > \$20,000 and < or = \$75,000
- 2017 Competitive Sealed Bidding > \$75,000

a. Board or Commission Member, State Employee

Conflict 7:

As written, a board or commission member, state employee, or the spouse or immediate family member of either of these can only:

- Enter into a contract, lease, or purchase agreement if they are the result of a competitive sealed bid or request for proposal, which is currently > \$75,000.
- Enter into a contract, lease, or purchase agreement, or grant that is > or = \$10,000 and < \$75,000 if prior written approval is received from the CFO of the State and notice is given to the Governor and Arkansas Legislative Council.

Prohibitions are:

- Contracts, leases, purchase agreements, or grants that are < \$10,000, whether approved by the CFO of the State or not.

Recommended Repeal: Conflicts

EO 98-04 allows a contract, lease, or purchase agreement that was the result of a competitive sealed bid or competitive bid; these require competition and disclosure. Any contract, lease, purchase agreement or grant not subject to competitive sealed bid and equal to the competitive sealed bid limit is permissible as long as there is a prior approval of the CFO of the State and notice given to the Governor and Arkansas Legislative Council.

b. Constitutional Officers (and their spouses)

Conflict 8:

A.C.A. § 21-1-403 (a) (1) allows a constitutional officer [to also include their spouse] to enter into a lease agreement, contract, or grant if it is awarded as a result of competitive bidding or a request for proposal and the constitutional officer played no role, directly or indirectly, in the administrative determination or specifications, evaluation or consideration, or decision to accept the bid or request for proposal. In the event that competitive bidding or a request for proposal was not required by law, the constitutional officer can obtain the prior approval of the Joint Budget Committee during legislative sessions or the Legislative Council between legislative sessions and the Governor.

EO 98-04 allows a constitutional officer [to also include their spouse] to enter into a contract, lease, or purchase agreement that are the result of competitive sealed bidding, provided, agencies shall be required to disclose any such contract, lease, or purchase agreement to the Governor and the Legislative Council. This is a conflict of A.C.A. § 21-1-403.

The term "competitive bidding" is not defined for A.C.A. § 21-1-403; however, according to § 19-11-234, competitive bidding includes contracts in which the purchase price exceeds \$20,000 and is less than or equal to \$75,000. "Competitive sealed bidding" as defined in § 19-11-229, shall be awarded through competitive sealed bidding for contracts exceeding an estimate purchase price of \$75,000. As written in A.C.A. § 21-1-403, a lease agreement, contract, or grant that would require a competitive sealed bid would require the prior approval of the Joint Budget Committee during legislative sessions or the Legislative Council between legislative sessions and the Governor.

Conflict 9:

Those contracts, lease, purchase agreements, or grants that are prohibited in EO 98-04 include any entity in which the constitutional officer (or their spouse) in which any such person holds (1) any position of control, or (2) any ownership interest of 10% or greater. In conflict, A.C.A. § 21-1-403 (d) does not include the term "any position of control;" it only requires an ownership interest of at least 10%.

Conflict 10:

A.C.A. § 21-1-403 (b) prevents any constitutional officer [to also include their spouse] from receiving any subgrant, subcontract, or assignment of any lease with a state agency unless the constitutional officer [to also include their spouse] is disclosed as a subgrantee or subcontractor in the competitive bid or request for proposal, or if competitive bidding or a request for proposal was not required by law, receives prior approval from the Joint Budget Committee during legislative sessions or the Legislative Council between legislative sessions and the Governor. This provision is more stringent than in EO 98-04, as the executive order only requires a disclosure by the constitutional officer.

Conflict 11:

A.C.A. § 21-1-403 does not include restriction on former constitutional officers or the spouse or immediate family member of the constitutional officer, which is a conflict with EO 98-04.

Recommended Repeal: Conflicts

Conflict 12:

EO 98-04 and the Rules do not place a time limit on the prohibition of contracting with former listed members; however, A.C.A. § 19-11-709(d) allows state employees to contract with the state after one year from the date that employment ceased.

<i>Determination Summary</i>	To Encourage the Reduction of Energy Costs by State Government and the Environmental Impact of State Government Operations The original intent of the EO was to encourage the reduction and energy costs by state government and the environmental impact of state government operations. This EO remains effective but is largely voluntary on the part of state agencies, and relies, in some part, on the Sustainable Energy-Efficient Buildings Act. No guidelines for development and implementation have been finalized for distribution to departments by the Department of Energy and Environment.			
<i>Executive Order Title</i>	21-21	12/20/2021	DIR	
<i>Determination Summary</i>	To Establish the Arkansas Energy Resources Council The Energy Resources Council remains operational. The Council provided a Tool Kit last fall for use by energy producers and users to prepare for potential energy disruptions during the winter season. There are no state or federal laws relating to this proclamation. The Council serves as a non-regulatory forum for the Arkansas energy industries, energy users, and state agencies to share information and discuss energy policy and energy resource availability in the state. Although the Arkansas Public Service Commission (PSC) has a regulatory role with respect to the state energy producers, the PSC structure does not provide for a non-regulatory process for the various energy producers and energy users to discuss and share information on the diverse energy issues in the state. This Council provides an important platform for energy industries, users, and state agencies to share information.

<i>Determination Summary</i>	Amending EO 18-01 Regarding the Office of Internal Audit The intent of this Executive Order was to amend EO 18-01 and to add additional provisions to the Office of Internal Audit within the Department of Inspector General. The provisions of this Order are necessary to conform to the standards of internal auditing.			
<i>Executive Order Title</i>	21-13	06/17/2021	DIR	
<i>Determination Summary</i>	To Establish the Office of Outdoor Recreation and the Arkansas Outdoor Recreation Advisory Board Codification has been considered, but the long-term agency placement of this office has not been decided. Grant programs that are administered by the Office have rules and policies, but they were not established by EO 21-13. The Department of Parks, Heritage, and Tourism (ADPHT) assigned them to the Office after its creation. The Office and Board were established to promote and grow the outdoor economy. This is still a primary goal of ADPHT. The Office Director is a member of the Arkansas First Advisory Council.

Agencies shall determine whether proposed rules affect small businesses
The original intent of the EO was to clarify definitions and procedures for adopting, amending, or repealing rules pertaining to small businesses in AR. While this order was effectively codified by the General Assembly in Act 143 of 2007, Act 759 of 2013 repealed Act 143 of 2007 in its entirety. Act 759 requires, in part, that agencies conduct a financial impact statement prior to adopting, amending, or repealing any rule. The financial impact statement must be a realistic statement of any new or increased cost or obligation of complying with the proposed rule on private individuals, entities, or businesses. Further, Act 759 requires any agency, prior to adopting, amending, or repealing any rule, to consider whether reasonable alternatives to the proposed rule. Despite the policies set out in this Executive Order 05-04 being reflected in Act 759 of 2013, the executive order should remain active. The Department of Commerce feels that more dialogue with Governor Sanders and her staff is necessary to assess whether a replacement EO is warranted so that agencies take into account monetary and non-monetary impact on small business.

DFA, either through the Economic Analysis and Tax Research or the Division of Revenue, publishes fiscal impact statements on tax related bills. The determination for continuation of this executive order will require an in-depth review to ascertain if the Department of Finance and Administration has knowledgeable staffing available to review each new program or spending proposals and potential private sector alternatives.
